We believe there's no-one better placed than our customers when it comes to recommending us and our product to other businesses and entrepreneurs. That's why we've put in place a referral program ("Referral") for those who want to spread the word. Find out how it works and what rewards are available to you right here..

### How to recommend Qonto to other businesses and entrepreneurs?

If you're a Qonto customer and you want to recommend us to other businesses and entrepreneurs, we've made it easy for you to do so. In short, you'll just need to:

- Lisez les présentes conditions générales d'utilisation.
- **Sign in to your app** and find your unique referral link in the "Referrals" section.
- Share your referral link with your contacts either directly in the app, or by copy-pasting it via any other means of communication of your choice.

### What is the Reward?

What Rewards are available to you and the business that's referring you? Referral is a win-win for all parties:

- The Referrer receives 80 euros;
- The Referee receives 80 euros.

This sum is known as the "Reward". The Reward that the Referrer and the Referee receive is the Reward amount applicable when the Referee signs their contract with Qonto.

### Who is eligible for a Reward?

To qualify for a Reward, both the Referrer and the Referee must meet all eligibility criteria as detailed below. Please note carefully that if any of these criteria is not met, neither the Referrer nor the Referee can receive the Reward.

You can be a Referrer if:

You are a Qonto customer and your Qonto account is activated.

#### You can be a Referee if:

- You have opened a Qonto account via the Referral link received from your Referrer;
- You have ordered at least one physical card;
- You have carried out one or more transactions with a physical card for a minimum amount of 50 EUR within sixty (60) calendar days following the account validation. Please note that cash withdrawals are not eligible to receive the reward.

The following card transactions are specifically excluded from the referral program:

- Cash withdrawals;
- All card transactions intended for fund transfers (for example: purchases of gift cards, money orders, purchases of prepaid cards, cryptocurrency purchases, traveler's checks, reloading a bank account by card);
- All card transactions in restaurants, bars, or tobacco shops, or related to betting, casinos, and other gambling activities.

### When will the Referrer and the Referee be credited with the Reward?

If eligibility criteria are all met, the Referee and the Referrer will receive the Reward within **seven (7) business days** following the validation of the Referral.

If you risk missing the Closing date deadline because your Referee has not activated their account, you can follow their Referral status directly from your app and send your Referee a kind reminder. At any time, you can send the Referee a pre-drafted message to remind them to finalize the process.

The Reward will be credited to the respective Qonto accounts of the Referee and Referrer.

- 1. Qonto reserves the right to suspend, terminate or amend these Terms and Conditions of Use ("T&Cs of Use") at any time and for any reason.
- 2. If we have good reason to believe that you are making fraudulent or wrongful use of the Referral, Qonto reserves the right not to pay the Reward to you or your Referred Persons and to take any other appropriate action. For example, using the Referral to open a Qonto account for the sole purpose of receiving the Reward constitutes a wrongful use of the Referral that may justify the closure of your account and/or that of your Referred Persons and the reimbursement of the Reward.
