## 1. What is the Special Offer?

Qonto is offering a limited number of special offers (the “**Special Offer**”) to certain clients (the “**Customer**” from May 12, 2025 to June 11, 2025 (the “**Promotional Period**”). The benefit of the Special Offer will apply for 12 months from the subscription date (the “**Special Offer Duration**”).

This offer is available only to new Customers who subscribe simultaneously to (i) an Essential Plan and (ii) the Expense & Spend Management (ESM) add-on.

- New Customers who subscribe to the annual pricing of both the ESM add-on and Essential Plan during the Promotional Period will enjoy the first month free of charge and then benefit from a discounted annual pricing rate of €99 per month instead of the usual €118 for 12 months from their subscription date.
- New Customers who subscribe for the annual pricing of both the ESM add-on and Essential Plan during the Promotional Period will enjoy a first month free of charge and then benefit from the discounted rate of €119 per month instead of €148 for 12 months from their subscription date.

It is important to note that the benefit of the Special Offer is only redeemable during the Promotional Period but will apply during the Special Offer Duration

## 2. How to take advantage of the Offer?

You must meet all of the eligibility criteria below (in section ‘*Who is eligible?*’), otherwise you will not be eligible to participate in this Special Offer.

### 2.1. Who is eligible?

Persons who are:

1. based in France, and whose business is registered in this country;

2. Opening a Qonto account for the first time during the Promotional Period;
3. Subscribing **both** to the ESM add-on and Essential Plan during the Redeem Period and who redeem the related Special Offer code in the Application or subscribe to the Special Offer through the dedicated landing page.

Only one (1) Special Offer may be redeemed per Customer.

### 3. How do I redeem the Special Offer?

A Customer eligible for the Special Offer after clicking through and accepting the terms and conditions of the Qonto payment account at onboarding as well as these terms and conditions of the Special Offer (the “**Special Offer T&Cs**”) will be able to redeem the Special Offer, applicable to new Customers.

### 4. How long will the Special Offer last for?

The Special Offer is valid from May 12, 2025 to June 11, 2025. After this time, Qonto standard price will apply if the Client has not redeemed the Special Offer.

Modifying your Plan and/or ESM add-on subscription or canceling it would void the Special Offer benefit.

### 5. What is the other important information?

- After the Special Offer Duration, Customers will be charged the standard ESM add-on and Essential Plan add-on fee automatically, except if they cancel the feature before the end of this period. After the Promotional Period, Customers won't be able to redeem the Special Offer.
- Qonto reserves the right to suspend, terminate or amend these Terms and Conditions at any time and for any reason or to revoke the benefits conveyed by this Special Offer if it deems appropriate.

- If Qonto has good reasons to believe that the Customer is making fraudulent or wrongful use of the Special Offer, Qonto reserves the right to revoke the benefits conveyed by the Special Offer and to take any further appropriate action.
- Except as otherwise provided in these Terms and Conditions, the Payment Service Framework Agreement of the Customer will remain in full force and effect.
- These Special Offer T&Cs are subject to French law and all disputes related thereto shall be submitted to the French court having jurisdiction, unless otherwise provided in the Payment Service Framework Agreement of the Customer.
