

Special Offer – Company Creation Netherlands

Terms and Conditions

1. What is the Special Offer?

Qonto is offering a limited special offer (the "**Special Offer**") to new clients who create their company through Qonto's Company Creation service in the Netherlands (the "**Eligible Customers**").

Eligible Customers will receive a 12-month free subscription to a Qonto plan. Instead of the standard free trial period, Eligible Customers can use Qonto free of charge for 12 months from the date of their account opening.

2. Who is eligible?

To be eligible for the Special Offer, customers must meet all of the following conditions:

- The customer must have created their company through Qonto's Company Creation service in the Netherlands;
- The company created must be a BV (besloten vennootschap) or a Holding BV;
- The customer must open a Qonto business account following the completion of the company creation process;
- The customer must have successfully completed Qonto's onboarding and identity verification process, and the business relationship must have been validated and approved by Qonto;
- The customer must not already have an existing Qonto account or plan at the time of the company creation.

The Special Offer is limited to the first twenty (20) Eligible Customers whose business relationship has been validated and approved by Qonto (*ie. KYB validated*). Once this cap is reached, the Special Offer will no longer be available, regardless of the end date set out in Section 4 below.

3. What does the Special Offer include?

The Special Offer grants Eligible Customers a waiver of the monthly subscription fee for a period of 12 consecutive months, starting from the date the Qonto account is activated (the "**Promotional Period**").

At the end of the Promotional Period, the Eligible Customer's plan will automatically renew at the standard subscription price applicable at that time, unless the customer cancels their plan before the end of the Promotional Period.

Services, fees, and charges not covered by the monthly subscription fee (including, but not limited to, transaction fees, card fees, or additional services) remain payable in accordance with the applicable Pricing Terms throughout the Promotional Period.

4. How long will the Special Offer last?

The Special Offer is valid for company creations initiated through Qonto's Company Creation service from 1st April 2026 for the twenty (20) first eligible customers, unless extended or terminated earlier by Qonto in accordance with Section 5 below.

5. What is the other important information?

- Qonto reserves the right to suspend, terminate, or amend these Terms and Conditions at any time and for any reason, or to revoke the benefits conveyed by this Special Offer if it deems it appropriate.
- The Special Offer is non-transferable, cannot be combined with any other promotional offer, and has no cash value.
- If Qonto has good reasons to believe that the Eligible Customer is making fraudulent or wrongful use of the Special Offer, Qonto reserves the right to revoke the benefits conveyed by the Special Offer and to take any further appropriate action, including the immediate termination of the Qonto account.
- The Special Offer is limited to one (1) per company created through Qonto's Company Creation service.
- Except as otherwise provided in these Terms and Conditions, the general Qonto Terms and Conditions (T&Cs) will remain in full force and effect.
- These Terms and Conditions shall be governed by and construed in accordance with Dutch law. Any dispute arising out of or in connection with these Terms and Conditions shall be submitted to the competent courts in the Netherlands.
